General Information:

- Doors open at 8:15 am. Play begins at 9:00 am.
- Each team is responsible for supplying their own volleyballs for warm-ups.
- Teams will be required to supply two line judges a scorer/libero tracker and scorebook keeper when their team is not scheduled to play. You will line judge for your pool if you are not playing on that court
- **Please Limit Carry-ins** – Concessions will be available and proceeds will go to AHA and PWVB.
- Backpacks and personal items should be placed at the table in the mid-level cafeteria at your team's designated table. Please keep all backpacks out of the seating areas for the fans to sit.

- Coaches/Officials Meeting will be held in the lower-level lobby at 8:25am.
- Warm-ups begin at 8:40am (Warm-ups are 6-7-7); – Teams may choose to bypass their portion of the warm-up). After the first pool play match a warm-up format will be 4-4 and can be bypassed

Court Locations: 3 courts will be in the main gym at Port Washington Highschool and 1 in the Auxiliary gym



Tournament Format: There will be 4 Pools of 3 teams. Matches will be played in a best of 3 format with no point cap. 3rd sets will be played to 15 with no point cap. The top team in each pool will advance to the GOLD bracket, the second team will advance to the SILVER bracket, and the 3rd team will advance to the BRONZE bracket.

Standings will be based on match wins. Set % will determine tie breakers, followed by point differential. As a last resort we will use a coin toss.

All teams are guaranteed 4 matches, best of 3 sets. In the Bracket round teams not playing are responsible to line judge or score

Match / Tournament results: All results will be tracked online via google sheets here. Results will be available via QR codes on various posters throughout the venue.

Breaks: There will be a 30-minute lunch break from 12:00 to 12:30 (or thereabouts) @ the conclusion of round 3 of pool play. Bracket play will start following lunch break (no later than 12:45pm) Playoff matches will begin promptly with warm-ups at 12:30 depending on pool play.

Scoring & Line Judging: Work teams are assigned for each match, BUT the PW JV Boys & Girls programs will try to fill as many roles as possible to reduce and eliminate the need for teams to fill in. Be on standby in case your team is assigned to work. You are responsible for the court you most recently played on if you are sitting (please verify if you are needed)

Concessions & Team Tables: There will be a concession stand that serves food and drink. There will also be 12 team tables available in the upper and lower cafeteria for teams to place their belongings etc throughout the day. Coaches and officials will be given a meal ticket to get a burger hotdog, chips and drink from the concession stand
